- Bids will be opened in the presence of bidders' representatives who choose to attend at 13:00 hours on 5th January, 2020 (20th Poush , 2076 BS). for all contracts at the office of Sunwal Municipality, Sunwal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the bid validity period. The original bid bond guarantee letter should be issued in the name of the office by any Commercial (Banijya) Bank, recognized by the Government of Nepal. Only the bid security guarantee letter in the format specified in the bid document will be accepted. Or Bidder who chose to deposit the bid security in cash shall deposit the cash and submit receipt the voucher from the bank listed above.
- If the last date of bid purchasing, submission, opening and pre-bid meeting falls on a government holiday, then the date for the applicable event shall be extended to the next working day. In such case the validity of bid security shall be considered from the originally specified last date for bid submission.
- Any conditions not covered so far shall be as per FAR 2056 (Latest Revision), Procurement Act 2063, and Procurement Regulation 2064 (fourth amendment).
