Bidders who choose to purchase the bidding documents from the office, shall be required to deposit the cost of bidding document as specified above in the Municipality's Rajaswa (Revenue) account during office hour. and can be purchased within 15 days from the notice. **17:00 hours on 26<sup>th</sup> March, 2017 (12 chaitra, 2074 BS).**

Sealed Bids must be submitted to the above office of Sunwal Municipality, Office of the Municipal Executive, Sunwal, Nawalparasi on or before 16<sup>th</sup> day from the notice by **12:00 hours on 27<sup>th</sup> March, 2017 (13 chaitra, 2074 BS).** Documents received after this deadline shall not be accepted. Late bids will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on **27<sup>th</sup> March, 2017 (13 chaitra, 2074 BS)** at the office of Sunwal Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **listed below** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
